Textual Information(1)

1. The Nomination & Remuneration Committee (also referred to as the Compensation Committee), at its meeting held on 31st December, 2025, has approved and granted 1,24,500 (One Lakh Twenty-Four Thousand Five Hundred) stock options at an exercise price of Rs.152.31 (Rupees One Hundred Fifty-Two and Thirty-One Paise only) per option to the eligible Team Members of the Company, in accordance with the provisions of the Pakka Team Stock Option Scheme 2021 (TSOP 2021) and subject to the terms and conditions stipulated therein. 2. The Consortium Lenders of the Company have, vide their Letter No. COMM/AMT/2022-23/25 dated 27th May, 2022, accorded their approval for the release of pledge on 1,59,10,156 (One Crore Fifty-Nine Lakh Ten Thousand One Hundred Fifty-Six) equity shares, representing 41.78% of the total paid-up share capital of the Company, held by the Promoters and Promoter Group. The said approval was duly intimated to the Stock Exchanges by the Company vide its letter dated 28th May, 2022. 3. Further, State Bank of India, being the then Consortium Leader for the existing credit facilities availed by the Company, vide its Letter No. COMM/AMT/2023-24/46 dated 30th January, 2024, has communicated the approval of the consortium comprising State Bank of India, Punjab National Bank, Union Bank of India and UCO Bank for the release of pledge on 1,59,10,156 equity shares pledged with them. 4. Out of the aforesaid pledged shares, 1,42,36,342 (One Crore Forty-Two Lakh Thirty-Six Thousand Three Hundred Forty-Two) equity shares held by the Promoters and Promoter Group have been released by the Banks during the quarter. 5. The procedure for release of the balance 16,73,814 (Sixteen Lakh Seventy-Three Thousand Eight Hundred Fourteen) equity shares is currently under process. A separate intimation shall be made to the Stock Exchanges upon completion of the release of the remaining pledged shares held by the Promoters and Promoter Group of the Company.
