1. Ld. Authorized Representative for the Petitioner Companies states that in the order dated 27.01.2026 passed in CP (CAA) No.01/ALD/2026 the following rectification are prayed for :-

- a) *Take on record the complete compliance made by the Petitioner Companies pursuant to the Order dated 27.01.2026 passed by this Hon'ble Tribunal in the above-mentioned Company Petition.*

2. The publication has been made in the Hindi newspaper, 'Amrit Vichar' in place of 'Rashtriya Sahara', as according to the Ld. Authorized Representative for the Petitioner Companies that the 'Rashtriya Sahara' is out of circulation as the publication has been discontinued. She also states that since the publications were to be made, and therefore the liberty has been taken to publish it in 'Amrit Vichar', and therefore she prays for *ex-post facto* approval of the same.
3. In view of the prayer so made by the Ld. Authorized Representative for the Petitioner Companies, we therefore approve the publication having been made in 'Amrit Vichar' in place of 'Rashtriya Sahara', which was originally ordered on 27.01.2026.
4. Another correction is prayed for that in the said order, the name of the company has been shown as "AKKA Impact Limited" instead of "PAKKA Impact Limited".
5. The above said corrections are made in the order dated 27.01.2026 and the remaining part of the order would remain the same.
6. Accordingly, the present IA No.16/2026 stands disposed off.
