Textual Information(1)

1. The Company wishes to inform that the erstwhile consortium arrangement of lenders, which included State Bank of India (as lead bank), Punjab National Bank, Union Bank of India and UCO Bank, pursuant to the Companys earlier credit facilities, no longer subsists as on date. In this regard, it is further submitted that the then consortium lenders, vide Letter No. COMM/AMT/2022-23/25 dated May 27, 2022, had accorded their approval for the release of pledge over 1,59,10,156 (One Crore Fifty-Nine Lakh Ten Thousand One Hundred Fifty-Six) equity shares, representing 41.78% of the paid-up equity share capital of the Company, held by the Promoters and Promoters' Group. The said approval was duly intimated to the Stock Exchanges vide the Companys letter dated May 28, 2022. Subsequently, State Bank of India, in its capacity as the then consortium leader, vide its Letter No. COMM/AMT/2023-24/46 dated January 30, 2024, conveyed the approval of the aforesaid consortium lenders for the release of pledge over the said 1,59,10,156 equity shares. Pursuant to the aforesaid approvals, 1,42,36,342 (One Crore Forty-Two Lakh Thirty-Six Thousand Three Hundred Forty-Two) equity shares held by the Promoters and Promoters' Group have since been released from pledge by the respective lenders. The release of the remaining 16,73,814 (Sixteen Lakh Seventy-Three Thousand Eight Hundred Fourteen) equity shares is under process at the level of the concerned lender(s). The Company shall make a further appropriate disclosure to the Stock Exchanges upon completion of the release of the balance pledged shares. 2. The Company confirms that 9,68,640 equity shares held by Yash Agro Products Limited (forming part of the Promoter Group), constituting its pre-preferential shareholding, have been duly locked-in in accordance with Regulation 167(6) read with Regulation 167(3) of the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018. The aforesaid lock-in is effective from April 14, 2026 and shall continue up to September 30, 2026 (both days inclusive). 3. We wish to inform that 36,00,000 fully convertible warrants were allotted on October 14, 2024, on a preferential basis. No warrant holder exercised the option for conversion within the stipulated period of 18 months from the date of allotment (i.e., up to April 13, 2026). Accordingly, in terms of Regulations 162(1) and 169(1) of the SEBI (ICDR) Regulations, 2018, the said warrants have lapsed and the upfront amount of 25% stands forfeited, resulting in no change in the shareholding pattern of the Company.
